

# **Acceptable Use Policy**

This Acceptable Use Policy ["AUP"] applies to all Summit Telephone Company ["STC"] products, services ["Service"] and subscribers, unless otherwise specified in written product-specific terms and conditions. STC reserves the right to change or modify the terms of this AUP at any time, effective when posted on STC's website at www.summittelephonecompany.com. The Customer's use of the services after the AUP is posted and/or changes to the AUP are posted shall constitute acceptance of the AUP and/or any changed or additional terms. STC reserves the right to update this policy from time to time without notice to subscribers.

#### **Acceptable Use**

The You Customer / Subscriber agree not to use this Service to:

- 1. invade another's privacy;
- 2. distribute lists to be used via unsolicited electronic mail or other mass electronic mailings including but not limited to: mass-news postings, SPAM and unsolicited email sent from your server, or any other service on the Internet, which contains your domain name or any other domain name on STC's network;
- 3. unlawfully use, possess, post, transmit, display or distribute obscene material or child pornography;
- 4. post, transmit, or disseminate content which violates any proprietary rights of any third party, or that is otherwise unlawful;
- 5. post, transmit or disseminate objectional information, without limitation, constituting or encouraging conduct that would constitute a criminal offense, give rise to civil liability or otherwise violate any local, federal or international law, order or regulation;
- 6. access any other person's computer, software, or data of any other person without the knowledge and consent of such person;



- 7. upload, post, publish, transmit, reproduce, publicly perform, publicly display, or distribute in any way, create derivative works, or information, software or other material obtained through the Service which is protected by copyright or other proprietary right, without obtaining permission of the owner;
- 8. copy, distribute, or sublicense any software provided by STC except that You may make one (1) copy of each software program for backup purposes only;
- 9. alter, modify or tamper with the Service or permit other person to do the likewise;
- 10. restrict, inhibit or otherwise interfere with the ability of any other person to use or enjoy the Service, without limitation, posting or transmitting any information or software which contains a virus, lock, key, bomb, worm, Trojan horse or other harmful feature; or generating levels of traffic sufficient to impede others' ability to send or retrieve information;
- 11. disrupt, STC's network;
- 12. resell the Service or otherwise charge others to use the Service (the Service is for your personal use only within your business, domicile, apartment, dormitory room or barracks room and **Y**ou agree not to use the Service for operation as an Internet Service Provider or for any other business enterprise in competition with the Service);

#### **Transmitting And Viewing Content**

The customer shall also be responsible for on-going registration renewal fees in subsequent years.
